Questions and Answers from New Camper Presentations

- Will drop-off times be coordinated with Belknap?
 - Yes, we are coordinating with Belknap for check-in times.
- If my child is fully vaccinated, do you still need to arrive with a negative PCR test? And will they need to have the test on day 5?
 - Per current CDC guidance, fully vaccinated campers do not need to participate in surveillance COVID testing. They do not need a PCR test prior to arrival and will not need to be tested at check-in or on day 5.
 - o If the CDC guidance changes or State of New Hampshire requirements change for vaccinated campers, Huckins will update families of changes to our COVID procedures. If infection rates increase or if there is a COVID outbreak at camp we may need to change our procedures, including expanding testing of vaccinated campers. - Are staff required to be vaccinated?
 - We are not requiring staff to be vaccinated but we are strongly encouraging them to do so. We anticipate all counselors and program staff will be fully vaccinated by the start of camp.
- If my child's Covid test on check-in day is positive, will they need to go home? Will we get a refund?
 - Yes. If the result of your camper's check-in day rapid COVID test is positive, your camper will need to go home. We will offer families a tuition refund.
- Will campers staying for a month need a test between sessions? Will I be able to see my camper
 if they are staying for a month?
 - Unvaccinated campers and staff will be tested at the end of their 1st session, with negative results received prior to next session.
 - Visitors are not allowed at camp this summer, so parents will not be able to visit campers staying for a month.
- When will my child need to wear a mask?
 - Our plan for summer 2021 is "When We Mix, We Mask."
 - Although the CDC has relaxed mask requirements for vaccinated individuals, masks will be a key part of keeping the Huckins residential camp community healthy and at camp this summer. With much of our community unvaccinated, our Huckins plan includes "When We Mix, We Mask." Spending time with campers from other divisions and cabins is an important part of camp, so to make that happen safely, campers will wear masks when mixing with campers from other cabins and divisions where physical distancing is not possible. Masks do not need to be worn in the cabin, when seated at our cabin table at meals, when your cabin is more than 6 feet from another cabin, or at the waterfront for swimming or boating activities. We will also plan for mask breaks and are building a program day that allows for physical distancing so masks will not be worn all day.
- If a camper in a cabin tests positive for Covid on day 5, will all campers need to go home?

- If we have a positive COVID case this summer, all unvaccinated campers that are close contacts will need to go home to quarantine.
- A close contact is any unvaccinated individual that has been within 6 feet of the person that tested positive for 10 minutes or more in the previous 48 hours, masked or unmasked.
- We are building the program to allow campers to mix between cabins and divisions safely to reduce the risk of sending multiple campers home for a positive case. We will mix outdoors, with physical distancing and masks.
- Will there still be singing at meals?
 - No, we will not be able to sing at meals. However, we will plan other times in the day before or after meals, outdoors with physical distancing, where campers can safely sing and cheer!
- Can you have a free-time buddy with a camper outside your cabin? Division?
 - Because all waterfront and boating activities are unmasked, campers will swim with a buddy from their cabin. Staff will help to facilitate swim buddies so all campers that want to swim are able to.
 - After Day 5 testing, there will be more opportunities for campers from different divisions to interact at the waterfront.
- Will there be CIT cabins in each division?
 - There will be CIT training cabins in each division, but CIT's will not be living in camper cabins per CDC and state guidelines. CIT's will spend the day with their assigned cabin, will teach instructional activities, but will sleep in the Q cabin in the Junior Division.
- Will there be Vespers?
 - Yes! We will have vespers this summer outdoors where cabins can be physically distant so we can safely sing together.
- After day 5, can you be buddies with someone outside your cabin and division?
 - This is a great question that we are still working to answer. Our camp nurses and Medical Advisory Committee will actively assess the risk of a positive case after our day 5 tests. We will make this decision based on that risk assessment, our goal of keeping all campers healthy and at camp, and updates from the CDC, ACA and State of New Hampshire.
- Is the camp store open this year?
 - The camp store will not be open during camp for clothing. We will make sure campers have access to essentials such as toothbrushes, stamps, deodorant, etc.
- Will there be program days?
 - Yes! Our Program Directors are working with summer staff to create program days in line with our COVID safety guidelines and full of Huckins fun!
- Will there be out of camp trips?
 - No. We do not want to risk accidental exposure to COVID so we will not be taking out of camp trips. We will be planning new on-site "adventures" to make this summer special.
